SALT Discussion – Part 2 (1 1/4 hour) Exploring alternative pathways

Discerning pathways forward for Canadian contextualized ministry:

- a) Making SALT work for Canadian Ministries using JMAs
- b) Ask for General Secretary and Chief Administrative Officer positions to be Interim positions (like Executive Director-Canada); use 2 years to reimagine structure with more stakeholder input
- c) Revert to Original Plan of COD with an ED-USA and an ED-Canada and an Ecclesiastical Officer
- d) Have CRC-USA and CRC-Canada shift to a strong Ecclesiastical Fellowship model

- e) Alternative partnership models such as those within the RCA
- f) Others that arise spontaneously from the discussions in Part 1 *Format:*
 - 1. The basis of each option is presented in 2-3 minutes
 - 2. Delegates go into breakout rooms of 6-8 persons. Each breakout group is asked to discuss one of the above proposals for 10 minutes.
 - 3. After regrouping a reporter from each group shares pros and cons of the option they discussed.
 - 4. A show of hands or vote is taken to determine which 1 or 2 of these rises to the top
 - 5. A full group discussion follows of those one or two options

Definitions:

SALT – Structure and Leadership Taskforce (plan for bi-national ministry, leadership and structure adopted by the COD in May 2021, awaiting full Synodical endorsement in June 2022)

JMA's – Joint Ministry Agreements (legal documents approved by Canadian and US staff for each CRCNA ministry area that set out the purposes, goals, activities and outcomes, and provide details of the budget, staffing and the contributions of each party to the joint ministry. JMAs are prescribed by the Canada Revenue Agency for all registered charities working through an intermediary (partner).

COD – Council of Delegates (of which Canada Corp forms the Canadian part. The delegates of the US churches are referred to as Michigan Corp)

ED-USA & ED-Canada – Executive Director USA and Executive Director Canada
